The Italy – US Tech Business & Investment Matching Initiative: Overview and Program Highlights

The “**Italy – US Tech Business & Investment Matching Initiative**” emerged from the recent conclusions of the Italian Government Steering Committee for Internationalization.

The Working Group that promoted and coordinates the Program, includes on the Italian Side representatives from the **Ministry of Made in Italy**, the **Ministry of Foreign Affairs**, the **Conference of Regions and Autonomous Provinces**, **14 Italian Regions**, **Confindustria**, the **Transatlantic Investment Committee** and the **Transatlantic-Harmonic Foundation**. On the US side, the Program has started conversations with the **Department of State**, the **Department of Commerce**, Organizations from **18 States**, the **Tech Hubs Organization**, **Select USA** and the **US Chamber of Commerce**.

In 2024 the Program will focus on **Aerospace** and **Life Sciences** industrial sectors, also incorporating companies developing **AI solutions** to accelerate progress in these industries.



How we intend to implement Industrial Partnerships

The Program aims to foster industrial partnerships between Italy and the United States by enhancing mutual understanding, connecting advanced ecosystems, and encouraging investments. By leveraging also on a local-to-local approach, the Programs intends to strengthen ties between Italian and US Central/Federal and Regional/State Authorities and Agencies, so as to develop initiatives and tools to enhance:

- **Collaboration between our most advanced ecosystems:** promoting industrial friend-shoring / friend-sourcing initiatives and mutual enhancement in value chain positioning.
- **Collaboration in R&D and innovation:** Leveraging mutual specializations to drive advancements.
- **Collaboration in co-designing products, solutions, and services:** Addressing international market needs more efficiently and effectively.
